NOTICE CUM ADDENDUM TO THE SCHEME INFORMATION DOCUMENT / KEY INFORMATION MEMORANDUM OF SBI SILVER ETF FUND OF FUND (FoF)

All existing /New Systematic Investment Plan (SIP), Systematic Transfer Plan (STP) etc. offered by the Scheme will remain operational. Please note that during this suspension period, redemptions and switch-outs will continue to be permitted in accordance with the terms outlined in the Scheme Information Document.

The aforesaid suspension is temporary in nature and will continue only till further notice in this regard.

All other terms and conditions of the Scheme remain unchanged. This addendum forms an integral part of the Scheme Information Document / Key Information Memorandum of the above Scheme as amended from time to time.
